- J. Dann also reported that M&A standard empirical formula, space group, and Z has been made available to users for Rel 2018 in September. Approximately 30,000 entries have these inclusions. Columns are standard, but do not mention M&A because the idea will be to include other materials in the future.
- The M&A prototype structure tables now contain 7,930 entries (up from 7,100 last year).
